General Requirements for all documents:

- 2.5” top margin required on first page, All other margins on first page and all margins on subsequent pages to be 1/2”
- Letter and Legal sized documents accepted
- Minimum 10 point font required
- 300 DPI accepted for documents.
- Recording hours are M-F, 8:30 AM to 4:30 PM (Cut-off time, can submit documents any time)
- NOTE: County does not accept Deed/Conveyance documents electronically at this time.
